

In the name of God, Amen. I Henry Garnham of the Parish of Thorpe Le Soken in the County of Essex, being rather indisposed in Body, but of sound and perfect memory, thanks be to God for the same, cancelling all forms of Wills, do declare this to be my last Will and Testament, that is to say, In form and manner following-

Imprimis, I give devise and bequeath, unto my Daughter Elizabeth Garnham, all that my Copyhold Estate, Land & Tenements, situate in the parish of Thorpe aforesaid containing by estimation, 14 rods and now in my own Occupation, to hold all the said Copyhold Estate. Land & Tenements, & every the Appurtenances to the same belonging & which is surrendered to the use of this my Will, to her, her heirs, & Assigns for ever: provided such Legacies, as shall be hereafter named, be duly paid out of the same.

Item, I give and bequeath unto the above named Elizabeth Garnham, all mt Goods and Chattels & all other my effects, as are herein set down, binding the same with the abovementioned Estate, for the payment of the undermentioned Legacies, that is to say, seven silver spoons, 1 pair of sugar Tongs, 2 China Basons, 6 d[itt]o. Cups & saucers, 1 Tea Chest 1 Tea Board & waiter, 2 Dozen plates, 3 bowls, 1 Dish, 6 Becars, 6 Glasses, Glass mug, cruit, 5 Salts\_ One Clock\_\_one large dresser, 7 pewter Dishes, 12 d[itt]o. plates one large oval Table, 8 Candlesticks, Coffee mug, 2 Grid irons, knife box, 12 knives & forks, 6 Chairs, 1 Looking Glass, one Copper warming pan, 1 pair of Iron Racks, 1 Tea Kettle, 1 dripping pan, 1 Tea Board\_ In the Chamber, 1 Bed with Furniture, 3 Beds without Furniture, 1 Great Chair, 5 small d[itt]o. 1 Chest of Drawers, 1 Desk, 1 oval Table, 2 Tea Tables, 2 Huches\_ In the Backhouse, 3 Boilers, 1 Copper, 2 Saucepans, 1 large pr. of stilly[ar]ds\_ 1 woaden Trough, 1 Square Table, 1 Cupboard, 4 Vessels, 1 Churn\_ & in the Yard 2 Cows & 2 Heifers.

Item I give & bequeath unto my Daughter Charlotte, 7 silver Spoons, two China Basons, & 6 d[itt]o Cups & Saucers.

Item, my further will is, that the abovementioned Elizabeth Garnham, do pay out of the abovementioned Estate & Effects, the Lawful Sum of five pounds of Lawful Money of Gt. Britain, unto each of my other Children, as they severally come of Age, that is to say, to Henry £5.0.0. to Charlotte £5.0.0. to Homan £5.0.0. to Daniel £5.0.0. to Zellat £5.0.0. to Jonathan £5.0.0. & to John £5.0.0.

Lastly, I hereby nominate & appoint Jacob Thorpe of the parish of Thorpe, & Homan Garnham of the parish of Thorpe afores[ai]d to be Executors of this my last Will & Testament; revoking cancelling, and disannulling all former Wills heretofore made, and hereby ratifying and confirming this to be my last.
